PRESS STATEMENT BY THE MINISTER FOR KAMPALA CAPITAL CITY AND METROPOLITAN AFFAIRS ON THE IMPLEMENTATION OF PRESIDENTIAL DIRECTIVES ON PUBLIC MARKETS IN KAMPALA

TUESDAY 23RD MAY, 2023

On 17th November 2022, H.E the President issued directives regarding the running of City Markets and KCCA was directed to take full control of the management and administration of the markets immediately.

While KCCA has implemented this directive in most of the government markets, there are some markets that like City Abattoir (which runs both as a market and an abattoir), have not seen full effect of the directive. I would therefore direct and emphasize that there is need to have a full realization of this directive.

Accordingly, the KCCA administration teams in all markets should enforce these implementation guidelines on the running of the city markets immediately.

GUIDELINES FOR MANAGEMENT OF MARKETS

 The administration and management of the markets will be executed by KCCA appointed staff in the markets and accordingly deployed

 KCCA staff will carry out the duties of administration, sanitation and hygiene, revenue collection, law enforcement and all other incidentals for the efficient running of the markets

- 3) Revenue collection in the markets is the work of KCCA staff only. Any unauthorized collections in markets by non-KCCA personnel is illegal and anybody caught will face the harsh hand of the law.
- 4) Vendors will pay for their utility bills including electricity and water as shall be billed from time to time
- 5) The vendors' management committees appointed in the markets before this date are immediately disbanded and are not allowed to engage in any management and administration of markets whether directly or indirectly
- 6) Vendors' welfare SACCOs shall not be involved in the administration and management of markets.
- 7) Any person who will deviate from the above roles will be treated in accordance with the existing laws and policies.

MARKET DEPLOYMENTS

(KCCA management has here provided a list of Personnel that will run the management and administration of these markets. I would like to guide that KCCA publishes these names in the media to avoid confusion in deployment).

- Every Market shall have a Market Master and Administrator appointed by KCCA management. The full list of market Masters and administrators is hereto attached.
- 2. KCCA management has put in place the following categories of staff who shall work under the Market Masters and with their specific roles as indicated in the table below:



SPECIFIC ROLES OF MARKETS TECHNICAL TEAM

- i. Exercise general supervision and oversight over the affairs and operations of the market.
- ii. Keep a verified and updated database/register of all vendors in the market.
- iii. Ensure that all utility bills (electricity and water) consumed by vendors are settled on time.
- iv. Collect dues, fees and charges from the vendors in accordance with the existing laws and instruments.
- v. Ensure that trade order is maintained in the market all the time.
- vi. Handle grievances arising out of the law and order enforcement.
- vii. Ensure that Public health regulations are observed.
- viii. Ensure cleanliness in the market at all times.
- ix. Operate and maintain the public toilets.
- x. Manage and collect solid waste.
- xi. Provide quality and timely weekly, monthly and quarterly reports and data within the market.
- xii. Ensure that there is security both within and outside of the market area.
- xiii. Ensure that routine maintenance checks are carried out on all market installations.

Note:

Since the issuance of this directive there has been a lot of speculation in the social media, especially on Lufula (City abattoir) regarding the streamlining of the administration of these markets

I would like to assure all stakeholders that all the raised concerns have been brought to the attention of the investigative arms of government, and whoever is found culpable will be charged accordingly.
